ChipConnect Cable Assembly Revisions

Description of Changes

A REACH O5A ruling has changed its guidance on requirements for substances from 1000ppm by weight of product to 1000ppm by weight of article, including consumables. TE is replacing its flux with a halogen-free alternative to align with the new requirements. TE is also replacing its acetate tape with an alternative free of all restricted substances per TEC-138-702, after being notified by the supplier of the presence of TCEP (advisory notice and substance handling document attached). Finally, TE is changing its dust covers for all ChipConnect assemblies to improve protection of connector ends during shipping and handling. This change is considered by TE Connectivity as a; . Location of change, see There have been no changes to the existing parts, the drawings have been modified to show a new product offering. There have been no changes to the existing parts, this is a revision increase only.
