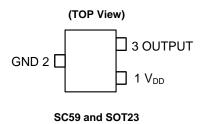


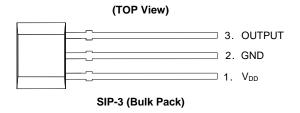

HIGH VOLTAGE ULTRA HIGH SENSITIVITY HALL EFFECT LATCH WITH INTERNAL PULL-UP RESISTOR

Pin Assignments





Description

The AH3382 is a high voltage ultra high sensitivity Hall Effect Unipolar switch IC designed for proximity, position and level sensing in industrial and consumer home appliances and personal care applications. To support wide range of demanding applications, the design has been optimized to operate over the supply range of 3.0V to 28V. With chopper stabilized architecture and an internal bandgap regulator to provide temperature compensated supply for internal circuits, the AH3382 provides a reliable solution over the whole operating range. For robustness and protection, the device has a reverse blocking diode with a Zener clamp on the supply. The output has an over current limit and a Zener clamp.

The internally pulled-up output can be switched on with South pole of sufficient strength. When the magnetic flux density (\mathbf{B}) perpendicular to the package is larger than the operate point (\mathbf{B}_{OP}) the output is switched on (pulled low) and is held on until magnetic flux density B is lower than the release point (\mathbf{B}_{RP}). The output remains switched off for North pole fields to or no magnetic fields.

The magnetic operating and release polarity is opposite for SOT23 and SC59 packages. The SOT23 and SIP-3 (Ammo Pack), SIP-3 (Bulk Pack) packages will require south pole to the part marking side to operate while SC59 will require south pole to the non-part marking side.

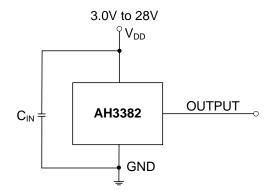

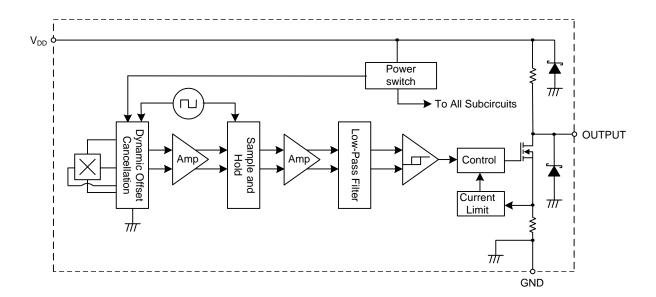

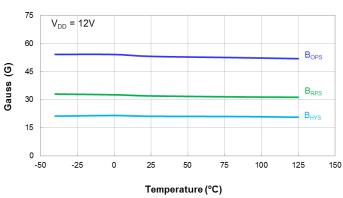

Output Switch Operate and Release Points (Magnetic Thresholds) - Bops and BRPS

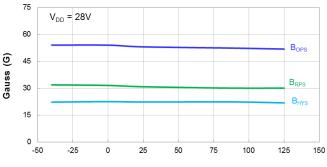




Switch Points Bops and BRPs vs Supply Voltage



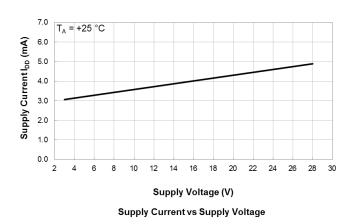
Switch Points B_{OPS} and B_{RPS} vs Temperature

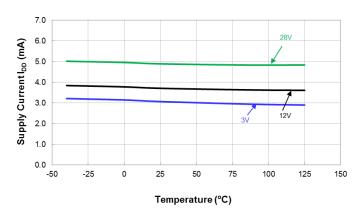


Switch Points \mathbf{B}_{OPS} and \mathbf{B}_{RPS} vs Temperature

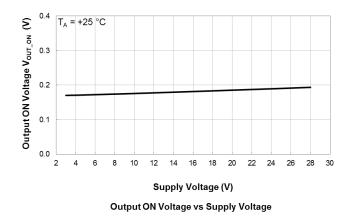


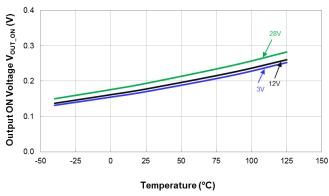
Supply Current vs Temperature

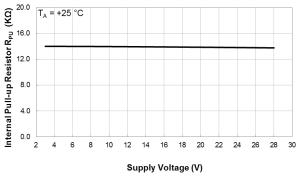
Output Switch On Voltage



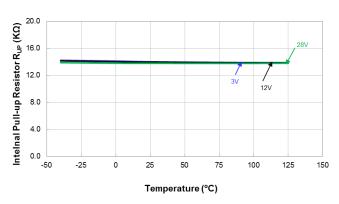


Output ON Voltage vs Temperature

Output Pull-Up Resistor (Internal)

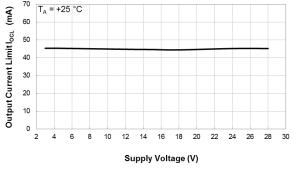


Internal Output Pull-up Resistor vs Supply Voltage

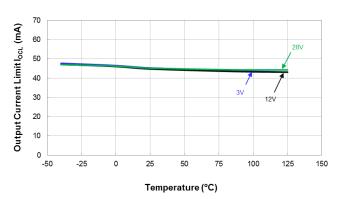


Internal Output Pull-up Resistor vs Temperature

Output Current Limit vs Supply Voltage



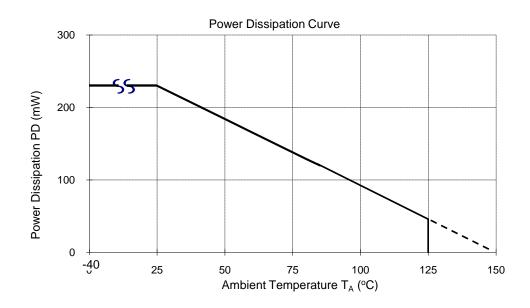
Output CurrentLimit vs Temperature

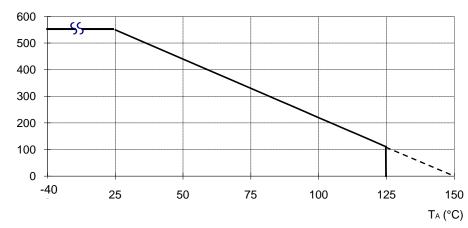

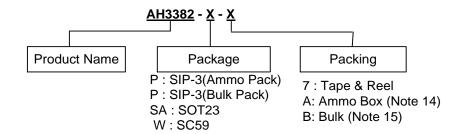


Power Dissipation Curve

Suggested Pad Layout

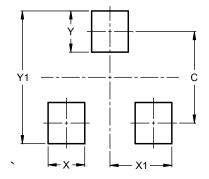
