






LED is recommended for reflow soldering and soldering profile is shown below.


Reflow Soldering Profile for SMD Products (Pb-Free Components)

- measured on the package body surface facing up during reflow.


 2. Do not apply any stress to the LED during high temperature conditions.

 3. Maximum number of soldering passes: 2









♦ Recommended Soldering Pattern (Units: mm; Tolerance: ± 0.1)

❖ Tape Specification (Units:mm)




Remarks:


- 1. Wavelength: +/-1nm

- 3. Forward Voltage: +/-0.1V


