Dual non-inverting Schmitt trigger with 5 V tolerant input

Product data sheet

1. General description

The 74LVC2G17 provides two non-inverting buffers with Schmitt trigger input. It is capable of transforming slowly changing input signals into sharply defined, jitter-free output signals.

Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in a mixed 3.3 V and 5 V environment.

This device is fully specified for partial power-down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the damaging backflow current through the device when it is powered down.




Fig 1. Logic symbol




Fig 2. IEC logic symbol




Fig 3. Logic diagram








Fig 9. Transfer characteristic






Fig 10. Definition of V_{T+} , V_{T-} and V_H

(2) Negative-going edge






Fig 14. Package outline SOT457 (SC-74)





Fig 15. Package outline SOT886 (XSON6)




Fig 17. Package outline SOT1115 (XSON6)




Fig 18. Package outline SOT1202 (XSON6)
