### CONNECTION

- 1. Connect the HDMI source to the TX.
- 2. Connect the TX to the RX with Cat5e/6 cable.
- 3. Connect the RX to the HDMI displays with HDMI cable.
- 4. Connect the IR TX cable to the IR port of the TX.
- 5. Connect the IR RX cable to the IR port of the RX.
- 6. Plug in the included power supplies to turn on the TX and the RX.

NOTE: Point to many configurations require different IP addresses and MAC addresses for each receiver.
