Description of Change:

Sharp is discontinuing the LQ121S1DG41 and LQ121S1LG41 LCD Modules to allow for subcomponent standardization. Drop-in replacement parts are available, and are fully form, fit, and functionally compatible.

The replacement for the LQ121S1DG41 module is the LQ121S1DG42; the replacement for the LQ121S1LG41 module is the LQ121S1LG42. These drop-in replacements are fully mechanical and electrically compatible. The Table below gives specific comparisons.

These obsolete part numbers will move to a category type "D" (Discontinued) classification effective immediately.
