Product data sheet

1. General description

The 74AXP1G32 is a single 2-input OR gate.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.

This device ensures very low static and dynamic power consumption across the entire V_{CC} range from 0.7 V to 2.75 V. It is fully specified for partial power down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.




Fig 1. Logic symbol




Fig 2. IEC logic symbol




Fig 3. Logic diagram




Fig 4. Pin configuration SOT886, SOT1115 and SOT1202 (XSON6)




Fig 5. Pin configuration SOT1226 (X2SON5)








Fig 7. Additional t_{pd} versus load capacitance


Fig 8. Additional t_{pd} versus load capacitance


Fig 9. Additional t_{pd} versus load capacitance


Fig 10. Additional t_{pd} versus load capacitance




Fig 13. Package outline SOT886 (XSON6)




Fig 14. Package outline SOT1115 (XSON6)




Fig 15. Package outline SOT1202 (XSON6)




Fig 16. Package outline SOT1226 (X2SON5)
