The following Phoenix Contact products have been modified. Existing specifications will be met or exceeded. Please review and acknowledge this document and inform your personnel as needed.

Description of Change:

The product change affects the current bar, the push button and the plastic housing. Each of these items has been modified to match our current PT design, reducing the amount of metal needed in each block while retaining the same electrical properties. Changes have also taken place on the PV and PE articles, optimizing the connection between current bars. Due to the change, PT 2,5-3PV (BU) and PT 2,5-3PE are only bridgeable at the lower level. Test connections designed for the bridging shaft will no longer fit the top or middle level, and must be installed on the bottom. Old and new designs are the compatible, the same shape, and can be mixed.
