Description for Product Discontinuation

Due to the introduction of a new line of hazardous location relays within the PLC relay family, legacy electro-mechanical relays for hazardous locations (PLC-R.../C1D2 & PLC-R.../ATEX) will be discontinued.

The new PLC..EX relays represent an expanded hazardous location relay family that now carries triple agency certification – UL CID2, <u>IECEx</u>, and ATEX Ex approvals. Traditional screw terminals are available, complimented by the new PLC..EX relays with PT push-in terminals that replace those modules with spring cage connection. The addition of all-new 10A single pole relays rounds out the PLC..EX portfolio.

The technical attributes of the new PLC..EX articles are virtually identical to the old articles, making migration to the new parts a straightforward process.
