Product data sheet

1. General description

Unidirectional double ElectroStatic Discharge (ESD) protection diodes in a common anode configuration, encapsulated in a SOT23 (TO-236AB) small Surface-Mounted Device (SMD) plastic package. The device is designed for ESD and transient overvoltage protection of up to two signal lines.

2. Features and benefits

- Unidirectional protection of two lines
- Reverse standoff voltage: V_{RWM} = 13 V
- Average measured surge robustness: $I_{PPM} = 14 \text{ A} (8/20 \mu \text{s}) / I_{PPM} = 2.54 \text{ A} (10/1000 \mu \text{s})$
- Typical reverse leakage current: I_{RM} = 0.1 nA
- Qualified according to AEC-Q101 and recommended for use in automotive applications




Fig. 1. 8/20 µs pulse waveform according to IEC 61000-4-5





Fig. 2. ESD pulse waveform according to IEC 61000-4-2




Fig. 4. V-I characteristics for a unidirectional TVS protection diode




Fig. 5. Relative variation of rated peak pulse power as a function of junction temperature; typical values




Fig. 6. Diode capacitance as a function of reverse voltage; typical values




Fig. 7. Rated peak pulse power as a function of a pulse duration; typical values




Fig. 8. Positive clamping voltage (8/20 μs pulse); typical values




Fig. 9. Negative clamping voltage (8/20 µs pulse); typical values





Fig. 10. Positive clamping voltage (10/1000 μs pulse); typical values




 t_p = 10/1000 µs; according to IEC 61643-321 Fig. 11. Negative clamping voltage (10/1000 µs pulse);



10. Application information

The device is designed for the protection of up to two unidirectional data lines from the damage caused by ESD and surge pulses. The device may be used on lines where the signal polarities are either positive or negative with respect to ground.



Circuit board layout and protection device placement

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

- 1. Place the device as close to the input terminal or connector as possible.
- 2. Minimize the path length between the device and the protected line.
- 3. Keep parallel signal paths to a minimum.
- 4. Avoid running protected conductors in parallel with unprotected conductors.
- 5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
- 6. Minimize the length of the transient return path to ground.
- 7. Avoid using shared transient return paths to a common ground point.
- 8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.

This product has been qualified in accordance with the Automotive Electronics Council (AEC) standard Q101 - *Stress test qualification for discrete semiconductors*, and is suitable for use in automotive applications.





Fig. 16. Package outline SOT23
