Subject: Addendum to PCN165006: Removal of Broadcom Logo and Company Name for Automotive IoT Products

Description of Change:

This addendum includes following updates to the affected parts.

- 1) Clarifying that all parts listed in this PCN will have the Broadcom logo and/or "BROADCOM ®" company name marking removed from the device marking.
- 2) The PCN has been updated to provide an example of the marking change for existing BCM ordering part numbers.
- 3) Removal of five parts from the affected parts list.
 - a. Three parts are not currently production status and are not planned to move to production (BCM89035CWMLG, BCM89335L2CRUBGT, and BCM89335L2CRUBG).
 - b. Two parts (BCM88072CRFB5G and BCM88072CRFB5GT) are not currently production status, and will begin as "CYW" devices once moved to production.
- 4) This addendum pushes out the implementation date to June, 2017.

The Broadcom logo and Broadcom trademarked company name will be removed on all package markings for existing Broadcom automotive marketing part numbers.

In addition, Cypress (CY) is pleased to announce the transition of the IoT products, formerly Broadcom (BRCM), from Broadcom automotive marketing part number nomenclature to Cypress automotive marketing part number nomenclature. New customer designs should use the new Cypress marketing part numbers instead of the Broadcom marketing part numbers.

The new Cypress automotive marketing part numbers differ only in the ordering part number, marking of the device, and marking format. There are no changes made to the product form, fit, or function and color of the marking on the new Cypress part numbers. With the exception of mark format and marking changes, the new Cypress marketing part numbers are identical to the existing Broadcom marketing part numbers.

Benefit of Change:

Conversion to the new Cypress marketing part numbers will bring consistency to the current IoT family of products and future products in development at Cypress.

Affected Part Numbers: 15

Affected Parts: All parts listed in this notice will have Broadcom owned markings removed from the device package marking. Four of the 15 products will have the Broadcom logo removed. Eight of the 15 products will have the "BROADCOM ®" marking removed. The remaining three products are not orderable devices but are included in this PCN for completeness. In all cases, the list of affected parts does provide the drop-in replacement Cypress marketing part number for new or future designs. Please refer to the attached 'Affected Parts List' file to identify your product and the marking change that will occur.

Qualification Status:

The new Cypress part number marking format has been verified to be consistent and meet the Cypress marking format specifications. All qualification and reliability documentation related to the current Broadcom marketing part numbers is unchanged, as there is no change to the form, fit, or function of the new Cypress marketing part numbers.

Sample Status:

Please contact your Cypress Sales Representative to request samples of the new Cypress marketing part numbers.

Approximate Implementation Date:

Cypress will begin the transition to removing the Broadcom logo and "BROADCOM ®" mark from the package marking by June of 2017.

Anticipated Impact:

The Broadcom logo and/or "BROADCOM ®" mark will be removed from the affected parts in this notice. No other changes are being made to the current Broadcom automotive marketing part numbers.

The new Cypress marketing part numbers using the Cypress standard mark format are fully compatible with the corresponding Broadcom marketing part numbers in terms of functional, parametric, quality and reliability performance. Customers are encouraged to update their ordering part number to the new Cypress marketing part number as shown in the attached spreadsheet.

Cypress also recommends that customers take this opportunity to review these changes against current application notes, system design considerations and customer environment conditions to assess impact (if any) to their application.

Method of Identification:

The Broadcom marketing part numbers affected by the Broadcom logo and ""BROADCOM ®" mark removal can be identified through the presence or absence of these markings. All additional marking information and format will remain the unchanged. Cypress maintains traceability of products to wafer level, including wafer fabrication location and assembly location, through the lot number marked on the package.

Identification of the new Cypress automotive marketing part numbers can be achieved by the part number marked on the package. The new Cypress marketing part numbers will include a part number prefix of "CYW", replacing the current prefix of "BCM".

Current BCM Part Number Marking Change Example:

The figures below detail the marking change that will occur on the current BCM ordering part numbers (example is given for the BCM89335L2CUBGT ordering part number).
