




Typical Temperature Rise vs. Current Characteristics:

Product specific:

Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- All other soldering methods are at the customers' own risk.
- To improve the solderability of bottom termination components please refer to appnote ANP036 on our homepage.
- Make sure that you use the correct thickness of solder paste to avoid an insufficient soldering result. We recommend 100µm solder
 paste as a reference.

Cleaning and Washing:

• Washing agents used during the production to clean the customer application may damage or change the characteristics of the wire insulation, marking or plating. Washing agents may have a negative effect on the long-term functionality of the product.

Potting:

If the product is potted in the costumer application, the potting material may shrink or expand during and after hardening. Shrinking
could lead to an incomplete seal, allowing contaminants into the core. Expansion could damage the components. We recommend a
manual inspection after potting to avoid these effects.

Storage Conditions:

- A storage of Würth Electronik products for longer than 12 months is not recommended. Within other effects, the terminals may suffer degradation, resulting in bad solderability. Therefore, all products shall be used within the period of 12 months based on the day of shipment.
- · Do not expose the components to direct sunlight.
- The storage conditions in the original packaging are defined according to DIN EN 61760-2.
- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.

Packaging:
