1. General description

The 74LVC1G98 is a configurable multiple function gate with Schmitt-trigger inputs. The device can be configured as any of the following logic functions MUX, AND, OR, NAND, NOR, inverter and buffer; using the 3-bit input. All inputs can be connected to V_{CC} or GND.

Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in mixed 3.3 V and 5 V environments.

This device is fully specified for partial power-down applications using I_{OFF}. The I_{OFF} circuitry disables the output, preventing the damaging backflow current through the device when it is powered down.








Fig 5. 2-input MUX with inverted output




Fig 6. 2-input NAND gate




Fig 7. 2-input AND gate with input A inverted or
2-input NOR gate with inverted C input




Fig 8. 2-input OR gate with input B inverted or
2-input NAND gate with input C inverted




Fig 9. 2-input NOR gate




Fig 10. Buffer




Fig 11. Inverter









Fig 14. Transfer characteristic

Fig 15. Definition of V_{T+} , V_{T-} and V_H






Fig 16. Transfer characteristic




Fig 19. Package outline SOT363 (SC-88)




Fig 20. Package outline SOT457 (SC-74)





Fig 21. Package outline SOT886 (XSON6)




Fig 23. Package outline SOT1115 (XSON6)




Fig 24. Package outline SOT1202 (XSON6)
