


Fig. 1. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values





Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values




Fig. 5. Forward current as a function of forward voltage; typical values; (logarithmic scale)





Fig. 6. Diode capacitance as a function of reverse voltage; typical values.





Fig. 8. Package outline DFN1412D-3 (SOT8009)
