Removal of 3-Year Date Code Shipment Restriction for Selected Configuration Devices (EPCQL; EPCQ 256Mb and larger)

Change Description

Intel Programmable Solutions Group ("Intel PSG", formerly Altera) is removing the 3-year (36 months) date code shipment restriction for select Configuration devices.

The seal date indicated on the moisture barrier bag (MBB) will remain as the reference for product shelf life relative to the moisture sensitivity level (MSL) of the devices.

Recommended Action

No action required. There is no impact to form, fit, and function of the devices. The removal of the date code restriction does not adversely impact the quality and reliability of the devices and the appropriate packing, storage, and shelf-life monitoring will continue to be applied to meet storage requirements of moisture sensitive devices.

Reason for Change

Intel PSG's current flash vendor is shutting down its production line for products that include the configuration device family. Intel PSG will continue to make available the EPCQL and EPCQ 256Mb and larger devices by building ahead 10-12 years of inventory for these specific devices. There are no changes applied to the build-ahead materials, these remain the same as the existing parts.
