1. Introduction

Over their lifetime, Skywire modems may incur several updates. These announcements are derived from communication from the module manufacturers, cellular carriers, and other related agencies relevant to the modem capabilities and technology. This PCN focuses on the EOL announcement from Telit on the LE910-SVG and LE910-NAG modules.

The Skywire modems listed in the table below are moving to Not Recommended for New Design, NRND, and will also be orderable only as Non-Cancelable, Non-Returnable, NCNR parts effective 06/07/2019. The End of Life (EOL) and the Last Time Ship Date are effective 10/31/2020.

2. Migration Overview

NimbeLink recommends the NL-SW-LTE-TC4NAG modem as the replacement for the NL-SW-LTE-TSVG-x and NL-SW-LTE-TNAG-x modems. The NL-SW-LTE-TC4NAG is a 4G LTE Category 4 device supporting both Verizon and AT&T in a single product. Replacing the EOL CAT 3 modems will require reviewing and updating the AT commands within your device design.

- Same AT commands
- Single product for both Verizon, AT&T and T-Mobile for USA
- Dual SIM architecture
- GNSS
- Expanded bands
