The wafer foundry for the VSC8601XKN, VSC8641XJF, VSC8641XKO, and VSC8641XKO-03 devices is discontinuing its wafer fabrication process for these parts. As a result, Vitesse is implementing a product discontinuation program for these devices to satisfy customer requirements.

Note that the VSC8211XVW and VSC8501XML devices are equivalent products in different packages, and they can be used in place of VSC8601XKN, VSC8641XJF, and VSC8641XKO. The VSC8501XML-03 device is an equivalent product in a different package, and it can be used in place of VSC8641XKO-03. The VSC8502XML and VSC8502XML-03 products offer an integrated dual-port alternative for customers using two or more VSC8601XKN, VSC8641XKO, or VSC8641XKO-03 devices in a design. Samples for VSC8501XML, VSC8501XML-03, VSC8502XML, and VSC8502XML-03 will be available in December 2013.
