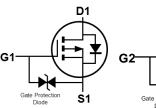

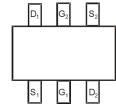

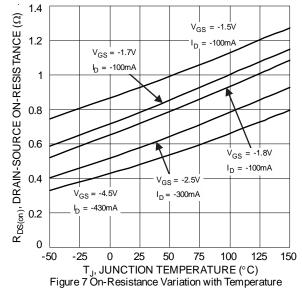

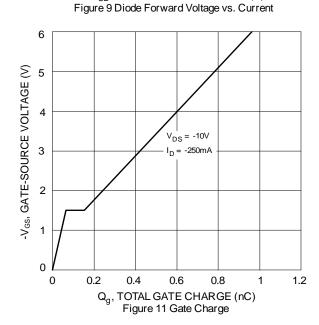

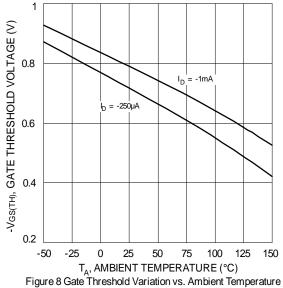
Figure 6 On-Resistance Variation with Temperature

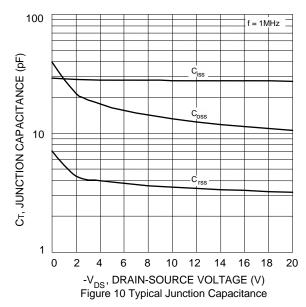


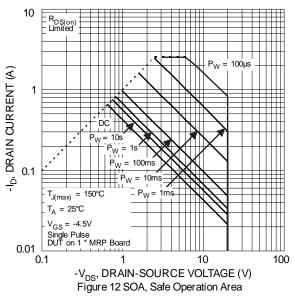














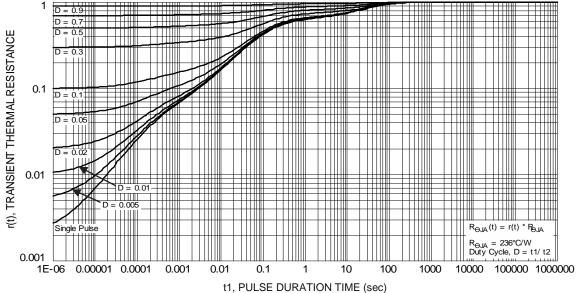
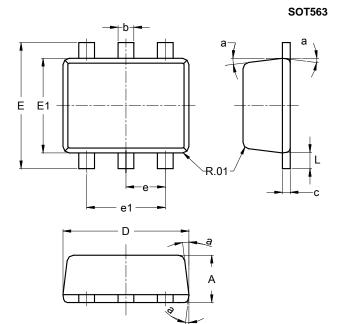


Figure 13 Transient Thermal Resistance

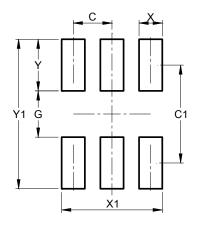
