### 1. General description

The 74LV244 is an 8-bit buffer/line driver with 3-state outputs. The device can be used as two 4-bit buffers or one 8-bit buffer. The device features two output enables ( $1\overline{OE}$  and  $2\overline{OE}$ ), each controlling four of the 3-state outputs. A HIGH on  $n\overline{OE}$  causes the outputs to assume a high-impedance OFF-state. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess  $V_{CC}$ .

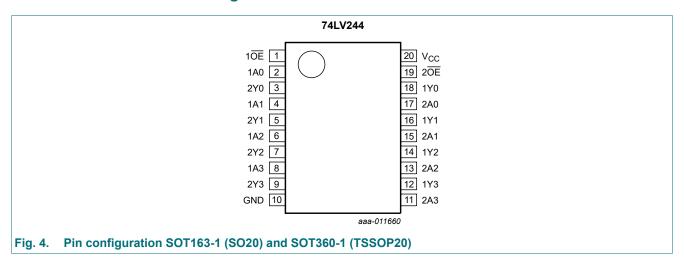

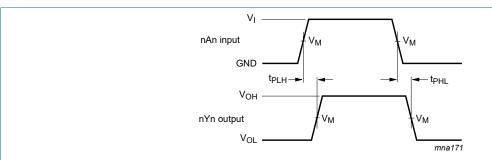

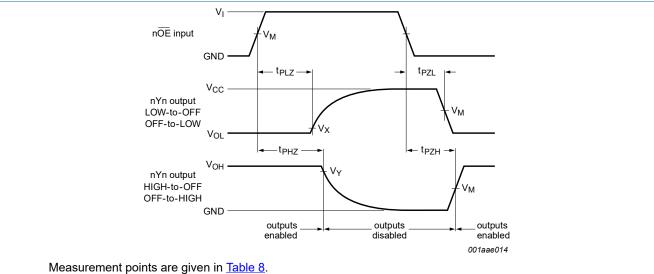
### 10.1. Waveforms and test circuit

Input (nAn) to output (nYn) propagation delays Fig. 5.



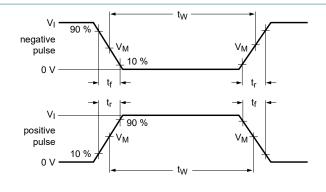

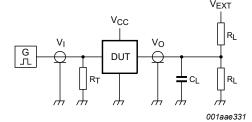

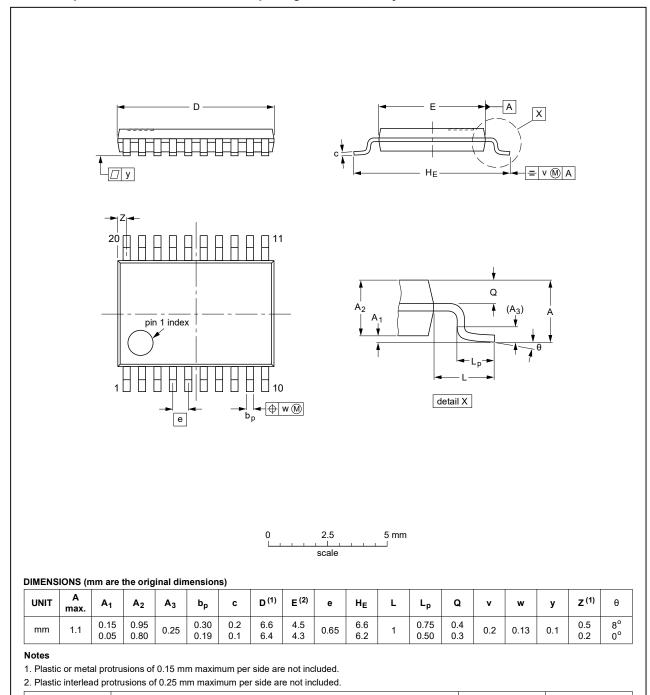
Fig. 8. Package outline SOT163-1 (SO20)
